**SUBJECT: FEBRUARY 2016 EMT/PARAMEDIC RECERTIFICATION**

As of November 2014, the State of Colorado is now requiring our members to complete their own EMT application online through COEMS Online Application Tracking Hub. **Denver Fire members that are within their recertification cycle will have 30 days beginning February 1st, 2016 to complete this process.** Members will log into [www.coems.info](http://www.coems.info) to access the application. The Username will be your six digit Colorado EMS provider number, including all zeros. Your EMS provider number can be accessed from the “Forgot Username or Password” tab or your district EMS Instructor. The Password will be your birth year plus the last 4 digits of your SSN. If members have questions or need assistance with the process, please contact your Denver Health EMS/CME Instructor. I have attached a PowerPoint for aid with this process as well.

A total of **thirty-six hours** of Continuing Medical Education (CME) and a **current CPR card** are still required before you can participate in the Colorado State EMT Recertification process. **Please check your CME hours via the web for EMS training history from the EMS Education Database to ensure that you have completed the necessary CME hours.** As a reminder, as of July 1, 2008, there are now 7 new categories for the required hours, up from the 3 categories previously required.

Upon receipt of this letter, you **shall** notify your supervisor that you are in the EMT recertification process.
