SUBJECT: NOVEMBER 1, 2016 C-SHIFT CPR RECERTIFICATION CLASSES

Attached is a list of DFD members who are in need of the CPR recertification. **Two** classes will be held on **C-Shift November 1, 2016**, starting promptly at **0900 and 1330** hours.

Operations District Chiefs and other Division Supervisors should notify the members within their respective Districts and/or Divisions. Classes will be held at the DHMC Rita Bass Educational Facility, 190 West 6th Avenue.

Attendance is **mandatory** for those on-duty members scheduled for recertification. Overtime is **not** authorized for CPR recertification when the member is on Kelly Day, is on vacation, or is off duty due to any other reason on the day that the classes are being held. Operations and the EMS Education staff will work together with affected members to provide additional classes for these members at a time when they are on duty. **The member is expected to be actively involved in the scheduling of their CPR recertification by contacting the EMS Education Lead Instructor at 303-668-8234 prior to their scheduled recertification class if they will not be present.** Members are reminded that unless they have a current CPR card, they will be unable to recertify as an EMT or Paramedic. Further, all members are required to hold a current CPR card even if they are not an EMT. *Please disregard any individual listed on the roster that may have recently recertified, retired, or transferred shifts, as the EMS database may not yet reflect those updates.*

DFD members who arrive in their private vehicles can park in the lot located on the east side of the Rita Bass Educational Facility. The code needed to access this parking area is 5063*. Remember that this code is only activated when a recertification class is being held and will not operate the gate at any other time. Additionally, EMS Instructors normally assign a person at the entry gate prior to the class to facilitate smooth entry into the parking lot. There is additional

parking in the lot on the south side of the facility; however, a fee is required to park there. If you have any questions or concerns, please contact me at 720-913-3495.
